



Ways to Give

Credit Card: Complete the attached form or call 209.588.5115 if you prefer.

Check: Make payable to Columbia College Foundation and enclose with attached gift form.

Payroll Deduction: Columbia employees can request a monthly deduction from their paycheck. Check the "Payroll Deduction" box on the form under "Method of Payment" and please do not forget to provide your signature on the signature line.

Gift of Stock or Other Property: Transfer stocks or real estate, for example, and receive gift credit for the market value. Contact the College President's office at 209.588.5115 for more information.

Pledge Monthly or Yearly Payments: When completing your contribution form, check the box marked "Pledge" and complete your desired payment schedule. Then, let us know how you would like to make your payments, by completing the "Method of Payment" section on the form.

In-Kind Gift (goods and services): Please contact the College President's office by calling 209.588.5115 to discuss your contribution.

Planned or Deferred Gifts: Please call the College President's office at 209.588.5115, if you think you might be interested in providing for the College through your will, a trust, an annuity, insurance policy, or other deferred gift type. We will be happy to discuss the options with you.
